The board of directors of TA Corporation Ltd. (the "**Company**", and together with its subsidiaries, the "**Group**") wishes to update that there have been no material developments since the Company's last monthly update on 8 August 2024 save for the following:

- (1) The Company has received no objection from Singapore Exchange Regulation to announce its financial statements for the report period commencing from 1 January 2024 to 30 June 2024 by 14 October 2024.
- (2) The disposal of Ascent@456 Properties (as defined in the shareholders' circular dated 10 July 2024) was completed on 26 August 2024.
- (3) As an update to the announcement made on 8 August 2024, TACC (C.R.) Ltd. ("**TACC**") has submitted to the Cambodian court to object the injunction order granted in favor of MCCO (Cambodia) Co., Ltd on the grounds that such order severely affects the rights and interests of TACC. Further updates will be announced as and when there are material developments.

**Trading of the Company's securities on the SGX-ST had been voluntarily suspended by the Company on 17 July 2023.**

**Shareholders of the Company and other stakeholders are advised to read this announcement and any further announcements by the Company carefully, and to exercise caution when dealing in the shares or other securities of the Company.
